INSTRUCTIONS TO VOTER

The following are instructions on how to vote your ballot. Please follow these instructions precisely, otherwise, your ballot may not be counted.

1. Verify that there are initials of an election official at the bottom of the ballot.
2. Verify that there are no voting marks on the ballot.
3. Use a black ink pen to mark the ballot.
4. **TO VOTE, you must darken the oval completely (●) next to either "YES" or "NO".**
5. Do NOT cross out or erase. If you make a mistake, write "Void" across the face of the ballot and contact your County Election Commissioner for instructions: Red Willow County 308-345-1552

Gosper County: (308)-785-2611
Furnas County: 308-268-4145
6. Place voted ballot into the Voter's Official Ballot Return Envelope. Write your NE driver's license or state ID in the space provided on the envelope, or enclose a photocopy of an acceptable photo ID or Reasonable Impediment Certification (if applicable). Complete, SIGN and seal the envelope. Remember to moisten both seals to cover the voter ID and signature boxes.
7. Any person physically unable to sign the envelope must make his/her "mark" and must have an individual witness. Failure to complete and sign the Return Identification Envelope will cause the ballot to be rejected.
8. **DO NOT PLACE MORE THAN ONE VOTED BALLOT IN THE Voter's Official Ballot RETURN ENVELOPE.**
9. Return Ballot by:
 - a. Hand Delivery - deliver the ballot to the office of your County Clerk/Election Commissioner.
 - b. Mail - return ballot by mail by placing proper return postage on the envelope.
 - c. Drop Box Location - Red Willow County: 502 Norris Avenue, McCook, NE
Frontier County: 1 Wellington Street, Stockville, NE
Gosper County: 507 Smith Ave, Elwood, NE
Furnas County: 912 R St., Beaver City, NE
10. Ballot MUST be in the possession of the County Clerk's office by 5:00 p.m. Central Time on August 12, 2025.

Cambridge School Bond

"Shall Furnas County School District 0021 (Cambridge Public Schools) in the State of Nebraska issue its bonds in a total principal amount not to exceed \$13,200,000 for the purposes of financing the costs of:

- Constructing certain additions to and renovations of its existing school building, including new classrooms, science labs, a family and consumer science lab, a multi-purpose room with stage, administrative offices, and other building and site improvements, and
- Purchasing certain necessary equipment, furniture, and apparatus for such building and additions;

said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rates, to become due to such times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?"
