On a motion by Mike Sexton, second by Dennis Tegtman, the Board agreed to purchase two new Schulte XH1500 S4 15' rotary mowers from Heartland New Holland. The purchase is made with \$4500 down, financing terms for five years with annual payments of \$4401, per mower. RCV: Shifflet, Aye; Tegtman, Aye; Sexton, Aye. The motion was declared carried by Chairman Shifflet.
