The Furnas County Board of Commissioners met Tuesday, January 14, 2025 for a regular board meeting in the Commissioners Meeting Room, 3rd Floor in the Courthouse. The agenda was emailed to each commissioner, posted on the County's website and kept current in the County Clerk's Office. Lois Bishop, County Clerk, opened the meeting at 9:00 a.m. and informed those present of the Open Meetings Act poster displayed on the wall and the provisions of the Act will be followed at this meeting. Ruth Russell, Treasurer office employee, told the Board she thought there should be carbon monoxide detectors in every office.
