He attended a conference in February for Continuing Education credits and will need to obtain more CE credits for the year 2025. The Board discussed opening communication and working relationship with the Road crews to help with better control and reporting of noxious weeds in the county. Weverka will set up a meeting/training with the Road Depts.
