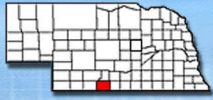
Pat Dodson, contracted with Furnas County to work with Child Support collections, met with the Board.

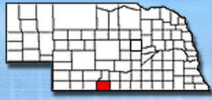

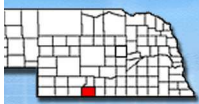

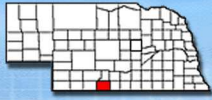
Donnie McCorkle and Rod Whipple, representing the Arapahoe Telephone Co., met with the Board to discuss probable tower use and related topics.
