REORGANIZATION FOR 2017

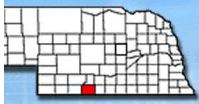

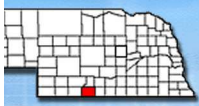
At that point, Chairman Lewis appointed Board member Spencer Shifflet to serve as Vice Chairman for the remainder of calendar year 2017.

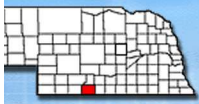
