

**FURNAS COUNTY BOARD OF COMMISSIONERS and BOARD OF EQUALIZATION
PROCEEDINGS FOR January 13, 2026**

The Furnas County Board of Commissioners met on Tuesday, January 13, 2026, for a regular board meeting in the Commissioners' Meeting Room, 3rd Floor in the Courthouse. Notice of the meetings was published in the Valley Voice newspaper and posted on the County's website. The combined agenda was e-mailed to each commissioner, posted on the County's website and kept current in the County Clerk's Office.

County Clerk Lois Bishop opened the meeting at 9:00 a.m. and informing those present of the Open Meetings Act poster displayed in the meeting room and that the provisions of the Act will be followed.

Board members present: Mike Sexton, Dennis Tegtman and Allan McCoy. Also present: Lois Bishop, County Clerk, Patrick Calkins, County Attorney.

Motion by McCoy, second by Tegtman to adopt Resolution 2026-1-13, Designating Banks as Depositories for Furnas County for the Calendar Year 2026: Banner Capital Bank, Beaver City; First Central Bank, Arapahoe, Cambridge & Edison; First State Bank, Cambridge & Holbrook; South Central State Bank, Oxford; Waypoint Bank, Cambridge; NFIT (NE Federal Investment Trust), Lincoln; NPAIT (PMA Financial Network), Naperville IL and Premier Bank, Lincoln. Motion by Tegtman, second by McCoy to certify the 2026 appointment of Lance Harter, as Contract Consultant basis, operating with Class A License, number S-1426, as Highway Superintendent for the calendar year, January 1, 2026 through December 31, 2026, for the purpose of the 2026 calendar year Highway Incentive Payment, to be issued to Furnas County by the Nebraska Department of Transportation in February 2026. BOARD OF EQUALIZATION: No items were brought before the Board; no meeting was held.

PUBLIC COMMENT: No one from the public attended the meeting.

Roger Powell discussed NIRMAs suggestions for signage in the county. Powell will check the State laws regarding signs.

Motion by McCoy, second by Tegtman to adopt Resolution 2026-1-13B - Certifying the Proper Completion of Project for Structures C003320410 & C003350450. RCV: Ayes: Sexton, McCoy, Tegtman. Motion carried.

Lance Harter, Oak Creek Engineering, discussed advertising for bids to construct Structure No. C003330215, 726 Road, E of Hwy 283, on Gosper County line and the shared work and cost with Gosper County. The ad will run for 3 weeks with bid opening on February 24, 2026.

Gregg O'Brien, NMC Caterpillar, discussed the purchase and financing of a 2026 CAT motor grader EB210321. Motion by Tegtman, second by McCoy to purchase a 2026 CAT motor grader, S/N EB210321, NASPO pricing of \$343,600.00 less trade-in of 2010 CAT 140M, S/N B9D02063 of \$57,500.00. Financing will be \$150,000.00 from Inheritance Funds, \$286,500 financed through CAT Financial.

Sheriff Doug Brown discussed new employee and training.

Burial Assistance Application was reviewed.

Motion by McCoy, second by Tegtman, to designate the Clerk of the District Court as full-time elected official. RCV: Sexton, McCoy, Tegtman. Motion carried.

After discussion and reviewing changes in legislation regarding budgets and commissioners' salary, a motion by McCoy, second by Tegtman to approve Resolution 2026-1-13A, Establishing Salaries for Elected Officials for 2027-2030 as follows:

For elected officials, the 2027 salary shall be the 2026 salary plus an increase based on the cumulative Consumer Price Index (CPI-U) as established by the Bureau of Labor Statistics, U.S. Department of Labor on the 12-month average from December 2025 to November 2026, plus 1%. The salaries for 2028 through 2030 shall be based on the previous year's salary, plus an increase based on the cumulative Consumer Price Index (CPI-U) as established by the Bureau of Labor Statistics, U.S. Department of Labor in November 2026, November 2027, and November 2028, plus 1%. The annual CPI-U increase shall not exceed 3% and, in the event of a CPI-U that is at 0% or less, officials and employees shall receive only the "plus 1%" increase. The full-time Chief Deputies for the County Clerk, Treasurer, Assessor, and Clerk of the District Court shall receive 70% of the elected officials. The County Commissioners and Chairmans salary for calendar years 2027 and 2028, shall be \$31,993.63. For calendar years 2029 and 2030, the annual salary for the office of County Board Chair and County Commissioners shall be established at \$31,993.63, plus an increase based on the cumulative Consumer Price Index (CPI-U) as established by the Bureau of Labor Statistics, U.S. Department of Labor in November 2027 and November 2028, plus 1%. The annual CPI-U increase shall not exceed 3% and, in the event of a CPI-U that is at 0% or less, officials and employees shall receive only the "plus 1%" increase. RCV: Sexton, McCoy, Tegtman. Motion carried.

There was no further business before the Board, Chairman Sexton adjourned the meeting at 1:30 pm. The next regular board meetings will be held on Tuesday, January 27, 2026, at 9:00 am or subject to call.
